

# Website (aonest.com) Terms and Conditions

## 1.) Introduction

a.) These terms and conditions explain how you may use this <a href="www.aonest.com">www.aonest.com</a> website ("Site"). References in these terms to the Site include the Site and all associated web pages. You should read these terms and conditions carefully before using the Site. By accessing or using this Site or otherwise indicating your consent, you agree to be bound by these terms and conditions and the documents referred to in them. If you do not agree with or accept any of these terms, you should cease using the Site immediately. If you have any questions about this Site, please contact support@aonest.com.

#### b.) **Definitions**

"Content" means any text, images, video, audio, or other multimedia content, software or other information or material submitted to, subsisting on or accessible from the Site;

"Services" means any offering related to the AONest web-based software system which is available for purchase through this Site, and/or available free of charge to selected individuals. Services include, but are not limited to, videos and worksheets via the AONest web-based software and the AONest Emotional Intelligence app;

"Subscriber" means any person who pays the required fee to subscribe to one or more of the Services and/or who is granted free access to subscribe to one or more of the Services;

"We", "Us" or "Our" means AONest Inc. whose registered office is at 236 Woodhaven Road, Kitchener, Ontario, N2C 1V5.

"You" or "Your" means the person accessing or using the Site or its Content and includes a Subscriber.

- c.) **Privacy Policy.** These terms include our Privacy Policy [AONest Privacy Policy] which shall be subject to these terms in the event of any conflict or inconsistency.
- d.) We grant each individual Subscriber using the Services a limited license to access and use (i.e., display, print, download) the materials and content within the Services solely for your personal, non-commercial use provided that: i) you do not disseminate or distribute our materials or Content publicly; ii) you retain all copyright, trademark or other notices; and iii) you do not sell or otherwise commercialize our materials or Content.



- e.) This Site is intended for and directed to residents of Canada over the age of 18 years.

#### 2.) Restrictions On Use
